## REGULATIONS

# of international children competition of drawings "Happy child – blooming World" - 2021

## I. GENERAL PROVISIONS

- 1.1. Slogan of the competition "Art defeats Duchenne"
- 1.2. Aim of the competition
- discovering and support of creative children and youth with Duchenne muscular dystrophy (hereinafter Duchenne) all around the World.
- facilitation of the creation of new forms of international collaboration;
- bringing closer the children and youth of different nationalities;
- enhancing the awareness about Duchenne in society

## II. ORGANISERS AND PARTNER OF THE COMPETITION

- 2.1. Organisers of the competition: NGO "Duchenne Ukraine" and charity fund "Happy child
- blooming Ukraine"
- 2.2. General partner of the competition:
- "Elisavetgrad" gallery, the town of Kropyvnytskyy
- 2.4. Organiser of the competition can engage other partners and sponsors for its conduction.

## III. CONDITIONS OF PARTICIPATION IN THE COMPETITION

3.1. Participants of competition can be children, teenagers and student youth of 5 to 18 years old, who have Duchenne/Becker disease:

I age group -5-10 years;

II age group -11-15 years;

III age group -16-18 years.

- 3.2. The subject of the competition is the artwork of the participants submitted for participation in the competition.
- 3.3. **Individual artworks** of authors are submitted for the contest.
- 3.4. Every participant can submit one work that is not returned.
- 3.5. Participation in the contest (except for the mailing cost) for all participants is free.
- 3.6. Drawings can be performed on any kind of material (graph paper, paperboard, canvas, etc.) and in any technique.
- 3.7. The size of competition artworks is 30x40cm (A3), drawings should be submitted without frames.
- 3.8. In 2021 following themes suggested for the competition:
- «The Earth- is our home»
- «Health is the main value in life»
- «Duchenne is a temporary disease»
- «My dream can come true»

- drawings having other themes, except for harassment and war
- 3.9. At the reverse side of the drawing there should be a label where the following information should be indicated with printed letters in **native and English languages**:
- full name and surname of the author;
- age of the author at the moment of creating the work;
- address (country should be indicated); return postal address and e-mail address, contact phone number of one of the parents (if available)
- 4.0 Drawings should be sent by registered post at the address of the gallery "Elisavetgrad" (36, Pashutinska street, the town of Kropyvnytskyy, Ukraine, 25006). The participant or his representative can hand over the drawing in person to the gallery located at the abovementioned address.
- 4.1. Drawings are accepted from 1 May to 31 September 2021 inclusive.

## IV. WORKS ASSESSMENT CRITERIA

- creative approach
- full depiction of the chosen theme
- level of mastering of the drawing technique
- drawing authenticity

#### V. WORKS ASSESSMENT CRITERIA

5.1. Competition is conducted once a year.

Drawings submitted for participation in the competition will be displayed at the gallery "Elisavegrad" after the announcement of the results.

- 5.2. Drawings, submitted after the deadline, will not be taken into consideration.
- 5.3. The jury compositions will be defined by the Organisers of the competition.
- 5.4. The winners will be announced by 1 November 2021.

## VI. WORKS EXHIBITION AND AWARDING THE WINNERS

- 6.1. The winners will be defined as a result of the summarising tour of the contest. Their works will form the exhibition at "Elisavetgrad" gallery arranged by the Organisers of the competition.
- 6.2. First, Second, and Third place will be defined in each category. The winners will get diplomas and encouragement prizes.
- 6.3 All participants of the competition will get a Diploma as a participant in an international competition.
- 6.4. Organisers of the competition will issue a brochure with the drawings of the winners. Organisers of the competition retain the right for printing the reproduction of the drawings and use of the kept drawings in other projects.

## VII. FINANCIAL REGULATIONS OF THE COMPETITION

- 7.1. The competition has the status of a non-commercial event.
- 7.2. Sources of funding of the competition are the funds of organizers, partners, sponsors and other sources not forbidden by local legislation.
- 7.3. Costs of mailing the drawings are borne by the participants of the competition.
- 7.6. Progress of the competition will be covered by the mass media, on the Facebook page of the competition "Happy child blooming World" and also on the page of the NGO "Duchenne Ukraine" and on the Internet.
